Degree Requirements

The academic regulations for this degree program, as entered in the University of Mississippi Catalog, are in effect for the current or selected academic year and semester. | REQUIREMENT | HOURS | DESCRIPTION |
|------------------------------|-------|--|
| Engl 600 | 3 | Student must complete Engl 600 . |
| Engl 797 | 18 | Student must complete at least 18 hours of dissertation credit (Engl 797). |
| Add'l course work | 6 | Student must complete an additional 6 hours of course work. Up to 6 hours may be taken in related disciplines and/or directed reading. Graduate instructors teaching freshman compositions are required to complete Engl 617 (Teaching College English). All courses must be approved by the student's GPC/Chair. |
| Adv candidacy exam | | Student must successfully pass the Advanced Candidacy Examination. |
| Dissertation prospectus | | Student must complete an approved dissertation prospectus. |
| Foreign language | | Student must demonstrate proficiency in one foreign language, usually Greek, Latin, Spanish, French, German, or Italian. Proficiency is defined as a genuine working knowledge of the language. Ordinarily, it would be demonstrated by a grade of B or higher in 3 hours of resident course work in the literature of the appropriate foreign language (in the original), by a score in the 40th percentile or higher in the Graduate Student Foreign Language Test administered by the Educational Testing Service, or by a grade of B or higher in Fr 599 , Germ 599 , or Span 599 , Special Topics: Translation for Foreign Language Proficiency. Anyone seeking to satisfy the foreign language requirement in a language other than those listed must petition the graduate studies committee. |
| Literature before 1800 | 6 | Student must complete 6 hours of course work in English or American literature before 1800. Each course must be approved by the student's GPC/Chair. |
| Literature after 1800 | 6 | Student must complete 6 hours of course work in English or American literature after 1800. All courses must be approved by the student's GPC/Chair. |
| Oral defense | | Every candidate for the Ph.D. degree must successfully pass a final oral examination (defense of dissertation) administered by the student's dissertation committee and scheduled by the Graduate School. |
| Submit Dissertation | | Student must submit a dissertation to his/her GPC/Chair. The dissertation must conform to the regulations governing style set forth in "A Manual of Thesis and Dissertations Preparations", available in the Graduate School Office. Two copies of the dissertation must be presented to the Graduate School after the final examination for the doctorate has been accepted and before the beginning of the regular examination period for the semester in which the candidate plans to graduate. |
| Theory course | 3 | Student must complete at least 3 hours in literary, critical, cultural, rhetorical, or composition theory. |
| GPA requirements | | A cumulative average of not less than 3.0 (B) must be achieved in all graduate work taken. |
| Liberal Arts Dean's approval | | This Degree Audit program is an advising tool only. The student must still apply for a degree by returning a completed Degree Application Form to the dean's office before the last day to add classes in the semester preceding the semester in which the student expects to graduate. The Dean's Office will make the final certification that the courses listed on the application qualify the student for graduation. The Dean's Office will also determine if other university requirements (GPA, etc.) have been met. |
